### PRELIMINARY & FINAL REGISTRATION

All entries, accommodation reservations, transport needs, flight arrival/departure information and visa invitation letter requests are to be completed using the World Archery Registration Online System WAREOS <https://extranet.worldarchery.sport>. This system handles the entire registration process for this event. No information related to entry forms, hotel reservations or transportation forms received outside the official registration website (WAREOS) will be accepted.

Member associations can log in to WAREOS at <https://extranet.worldarchery.sport> with the username and password assigned by World Archery. After entering WAREOS, selecting the event from the list will allow a member association to register their athletes. Select/press the “Entries” button to see the list of categories in the event. Select/press the “category” to enter the athlete and official numbers/details of those participating in that event. A WAREOS User Manual can be downloaded in PDF format (English) upon login.

Member associations that have penalty fees outstanding from 2024 will need to pay these penalty fees before being eligible to enter and compete.

Any entries received after the final registration deadline will be refused. Only substitution will be allowed.

Entries and substitutions received after the deadlines are subject to penalties as clearly stated in the rule book and the invitation documents of World Cups and World Championships. A Member Association that has made final entries in WAREOS and does not participate will be invoiced for the number of entries entered in the system as well as any other booking they made through the platform (including but not limited to accommodation, transportation, and any other extras the Member Association has booked through the platform).

Any outstanding balance remaining prior to the commencement of the competition relating to the addition/removal of members at the LOC office can only be paid by credit card or wire transfer.

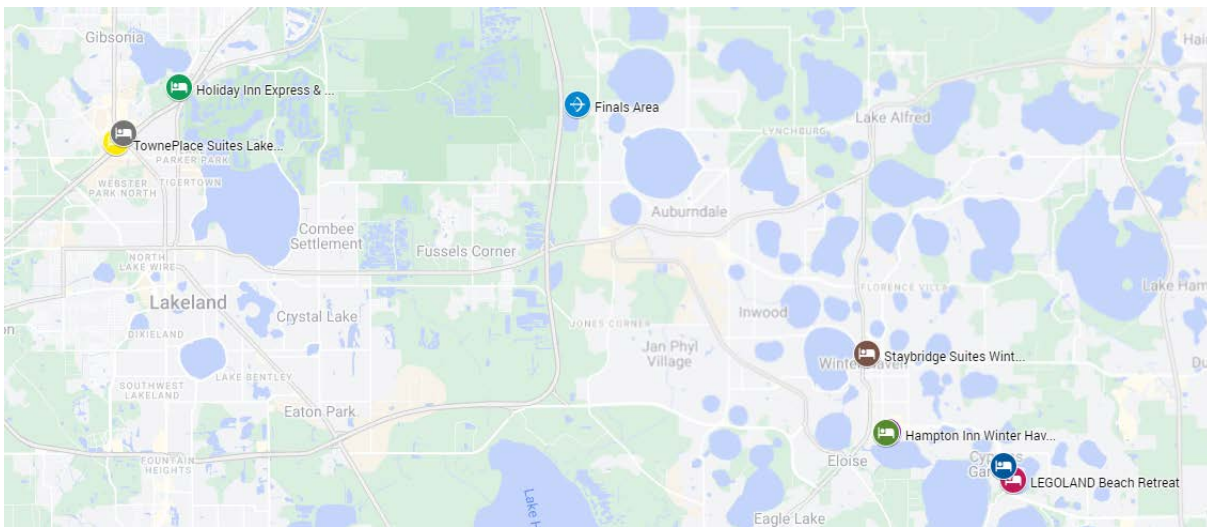

### TRANSPORTATION

Transportation will be provided to and from Orlando International Airport (MCO) to the official hotels, from Sunday 6 April 2025 until Monday 14 April 2025. The price for this airport transportation will be 70 USD each way per person for those staying at the LOC accommodation listed above.

Transport timetables will be confirmed at a later date.

### PARKING

### VISA

All participants who need an entry visa to the United States will be required to complete the Visa Support sections in WAREOS by no later than 1 February 2025.

It is the participant's responsibility to supply the necessary information, ensuring all details are up to date, correct and submitted by the deadlines specified.

In addition, all participants who require a visa are kindly requested to supply a copy of their latest/valid passport. Copies of each application can be uploaded on WAREOS. All passport copies and personal details entered/uploaded to WAREOS will be held securely and in the strictest of confidence and not shared with other parties.

It is the participant's responsibility to ensure they have the required official travel documentation for entry into the United States. Citizens of certain countries are eligible to apply for admission under the ESTA Visa Waiver Program. The ESTA website is: <https://esta.cbp.dhs.gov/>

It is in your best interest to fill out visa applications as soon as possible to ensure eligibility for the event

### TRAINING AND COMPETITION VENUE

The Competition, Qualification and Training venues are located in the same complex at Lake Myrtle Sports Park - 2701 Lake Myrtle Park Road, Auburndale FL 33823

The Training field will be available starting on 6 April 2025 at the venue located approximately 5 minutes' walk from the official qualification field.

There will be an additional charge of 20 USD per person, per day for transport between the practice venue and LOC official hotels only from 6 to 7 April 2025. This booking can be made through WAREOS

#### Article 1: Entirety

The platform <https://extranet.worldarchery.sport/wareos/> is the propriety of, has been designed and created and is managed by World Archery Federation at Lausanne, Switzerland, and put at the disposal of the Local Organising Committee to facilitate registration to World

Archery events. The present terms and conditions include any and all rights and obligations of the parties. #### Article 2: Object
